COINSTAR SELLS E-PAYMENT SERVICES BUSINESS TO INCOMM

ATLANTA and BELLEVUE, Wash.—May 26, 2010-- InComm and Coinstar, Inc. (NASDAQ: CSTR) today announced that InComm has purchased Coinstar's E-Payment services business, which includes operations in the United States and the United Kingdom. The aggregate purchase price was \$40 million, which is subject to a post-closing net working capital adjustment.

With the transaction, InComm has acquired a comprehensive prepaid product portfolio including approximately 400 individual prepaid card products from more than 65 unique issuers spanning various prepaid segments, including wireless, long distance telecom, branded retail gift, financial services, and digital entertainment.

"We are pleased to have found a great home for our E-Payment business with InComm, a prepaid industry leader. Our broad product portfolio and targeted distribution combined with InComm's solution will provide retailers an exceptional prepaid offering," said Paul Davis, chief executive officer of Coinstar, Inc. "Coinstar will continue to focus on our core strengths in automated retail to serve our consumers, retailers and shareholders."

"This acquisition will expand our retail opportunities, including broadening distribution in convenience stores and will give more consumers easy access to the flexibility of prepaid products," said Brooks Smith, chief executive officer of InComm. "The E-Pay team, including managers and employees, will be a great addition to InComm's team and we look forward to their contributions to the future growth of our business."

The transaction closed May 25, 2010. In addition, Coinstar filed a Current Report on Form 8-K that contains certain information regarding the transaction.
